



This map below is <u>NOT</u> drawn to scale. Southern Choctaw High School is located approximately 2 miles south of Gilbertown, Alabama, and approximate 5 miles north of the intersection of Highways 17 and 84 in Silas, Alabama.

To reach the school you turn off Highway 17 at the entrance immediately north of Southern Choctaw Elementary you should bear right, proceed up the slight incline, bear right again and follow the pavement to Southern Choctaw High School. As you approach the school the library is the big area in the middle of the front of the school. The principal's office is located immediately behind the library in that same portion of the building.
